TOPIC:

Refugees in Poland, Slovakia, the Czech Republic - statistics, procedures.





OBJECTIVES of the classes:

Presentation of statistical data showing the scale of refugees

in Poland/Czech Republic/Slovakia

TARGET GROUP: Students of primary schools.

WORKING METHODS: Film, brainstorming, group work, individual work, work

using ICT carriers (smartphones, computers).

discussion. DURATION: 1 teaching hour.

TEACHING RESOURCES: Multimedia projector, computer, film, flipchart, colored markers,

printed materials.
COURSE OF CLASSES:

PL version:

- 1. Ask the students what they think is the number of refugees in Poland?
- 2. Provide data of the Office for Foreigners:

According to the data of the Office for Foreigners, in 2020 applications for international protection in Poland were submitted by 2.8 thousand. people, including 1.5 thousand for the first time.

The most numerously represented countries of origin of foreigners are:

- · Russia 1283 people
- · Belarus 407 people
- · Ukraine 317 people
- · Afghanistan 120 people
- · Tajikistan 87 people

Write the numbers for the most represented countries on the board.

Submitted applications in 2020 - 2.8 thousand foreigners

- Ukraine 11.5%
- Belarus 14.8%
- Russia 46.7%
- other 27%

During the refugee procedure, foreigners can take advantage of social assistance (e.g. accommodation, meals, medical care) provided by the Office for Foreigners and educational activities (e.g. learning Polish, information courses). They have the choice of staying in the center or living independently outside the centers with financial assistance received from the office.

In 2020, almost 5.2 thousand people benefited from social assistance and medical care. people.



CZ version:

- 1. Ask students what they think is the number of refugees in the Czech Republic?
- 2. Provide details of the Ministry of the Interior of the Czech Republic:

According to the data of the Office of the Ministry of the Czech Republic:

In 2019, the largest number of people applying for international protection (i.e. asylum or subsidiary protection) in the Czech Republic came from:

- Armenia (372 people)
- Ukraine (311 people)
- Georgia (224 people)
- Vietnam (143 people)
- Kazakhstan (109 people).

In total, 61 asylums and 86 subsidiary protections were granted in the Czech Republic, representing less than 7% of all assessed applications. UPRCHLÍCI V ČÍSLECH https://www.clovekvtisni.cz/migracni-statistiky-4518gp

Number of asylum applications in the Slovak Republic in 2020

Citizens of Morocco, Syria, Turkey and Iran most often applied for asylum in the Slovak Republic

in 2020.

In 2020, the Slovak Republic granted asylum to 11 people.

For comparison: in 2004, 11,395 people applied for asylum in the Slovak Republic; in recent years, the number of asylum applications has stabilized at several hundred a year. Out of a total of 59,325 asylum applications since 1993, 874 were granted asylum and 792 were granted subsidiary protection as another form of international protection (Počet žiadostí o azyl v SR v roku 2020 - https://www.iom.sk/sk/migracia/migracia-na-slovensku.html)
